Several topics will be presented at this one-day symposium through lectures and Q&A sessions from UT Southwestern experts in the field of gastroenterology. This course is designed for gastroenterologists, GI surgeons, internal medicine physicians, family practice physicians, nurse practitioners, physician assistants, and other health care providers with an interest in gastroenterology.

- 9. Describe the criteria for choosing Endoscopic Mucosal Resection (EMR) and Endoscopic Submucosal Dissection (ESD) polypectomy for advanced lesions.
