PURPOSE AND CONTENT

Brain Summit 2024: Current Trends in Neurology is a one-day live CME activity designed for neuroscience neuroscience professionals - including physicians, advanced practice providers, nurses, and physical therapists - to explore latest advances and current trends in neurology clinical practice and patient care. Didactic presentations, case studies, and panel discussions will present the most current information and address clinical practice challenges for advancing proper diagnosis and best treatment modalities across a wide spectrum of neurological disorders.

- Review the challenges with ALS and its care from a patient's perspective.
